

# VOTE BY MAIL

## FREQUENTLY ASKED QUESTIONS

### WHY VOTE BY MAIL AND NOT IN PERSON?

Because Republicans are missing votes - and Democrats who vote from home aren't! The fact is that even with good intentions, fewer than 40% of voters get to the polls.

Mail-in voting makes sure you vote - because sometimes life gets in the way of getting to the polls.

**Mail-in voting is the key.**

### IS MY BALLOT SECURE?

**Every Mail-In Ballot is 100% secure.**

Election Day, a group of bipartisan volunteers count mail-in ballot votes at the county voting center in Norristown.

They are supervised by County workers and closely observed by attorneys from both Parties, leaving ZERO FRAUD OPPORTUNITIES. **You can even TRACK your mail-in ballot!**

### CAN I TRACK MY BALLOT?

**Yes, you can track your ballot - from application to receipt of your vote.**

When you apply, simply include your email address. You will then receive emails that your application has been received, when your ballot is being mailed to you, and when voter services has been received your mailed-back ballot.

---

### WHEN WILL I RECEIVE MY BALLOT?

**Ballots are usually mailed to voters 30-60 days before Election Day.**

If you include your email address when you apply, the county will email you when they mail your ballot so you can look for it in your mailbox. When you get your ballot, fill it out and return it immediately.

---

### WILL I RECEIVE A BALLOT EVERY ELECTION?

**No.** When you apply for your ballot make sure to apply for a "Permanent Ballot" or "Annual Mail In Ballot." When you do, you will receive a letter every year from the Board of Elections asking if you want to receive another mail-in ballot for that year's elections.

Make sure you request your ballot every year.

### CAN I STILL VOTE AT THE POLLS IF I GET A MAIL-IN BALLOT?

Not exactly. While you can still vote at the polls, you must remember to bring in the mail-in ballot you received and surrender it in order to vote in person.

If you forget your ballot, you will have to cast a provisional ballot that is then compared to see if you also voted by mail.

Secure a paper vote-by-mail application from a Republican Party volunteer - or - go online to [vote.pa.gov](http://vote.pa.gov) and click on "Mail-In and Absentee Ballot" - or - **scan this QR code.**



**2**

Complete your ballot application and when you do **make sure to include your email address so you can TRACK your vote** through the process.

**3**

**Vote and return your ballot right away** when you receive it from the county. You can return it by mail or at a secure dropbox location. **If you provided your email address when you applied, you will receive a confirmation email your ballot was received.**
